9.1 Cheshire East Council is due to fix its Taxbase for the financial year 2023/24 by Resolution of the Council on the 14<sup>th</sup> December 2022. The taxbase for your Parish Council area is likely to be 245.96 compared to a current amount of 238.09. **(refer to 9.1)**

*As an indication if the current band D council tax of (£13.76) remained the same, this would increase your precepts from £3,275 to £3,384. Alternatively, if the precept remained at £3,275 then the band D council tax would reduce to £13.32 when using the new tax base and adjustment factor.*
